hope that you all had a safe and enjoyable summer. It is always a welcomed break, but it is certainly nice to be back surrounded by my brothers. This summer was fairly quiet for the lodge officers, with only a couple of emergent meetings called to take care of business. As I watched the logistics of calling these unscripted meetings, I decided to do some reading and see what exactly the Constitution and By-laws lay out. By reading Title Four, Article 7, Section 2, Part 5, Emergent Communications, many of the questions I had were answered.

*Please Also Note:* Grand Lodge put out an updated revision of the Grand Lodge Constitution and By-Laws dated 07.31.2024 which can be found on Grand View.

#### Who has the Authority to call an Emergent Communication?

"The Master of a lodge may at any time order an emergent communication, or change the time of one already ordered; but no work may be done except such as is permissible at an emergent communication."

#### What happens if the Master is absent or sick?

"The Senior Warden, in an emergency, as in the case of the death, absence or sickness of the Master, so that his order cannot be had, may call an emergent communication of the lodge; and if the Senior Warden is similarly conditioned, as well as the Master, the Junior Warden may exercise the same authority."

We hear this all the time in our closing, but what is "Due and Timely Notice"?

"If an emergent communication is called, due and timely notice thereof must be given to each member of the lodge, if possible. The notice must contain a statement of the work to be done at such communication, which must be only such work as is permissible at an emergent communication."

## Are there any stated rules when you can NOT hold an Emergent?

"No lodge shall hold more than one emergent communication for the conferring of degrees in any one calendar day; and after having conferred any one of the three degree twenty-four hours must elapse before the same degree may be again conferred."

#### and

"The holding of emergent communications on Sunday for the conferring of degrees is expressly prohibited."

# I know these types of Communications are common for Funerals. Do the By-Laws specifically call out anything for Funerals?

"An emergent communication called for the purpose of conducting funeral services may, in the discretion of the Worshipful Master, be closed the same day, or on a date on which the lodge holds its next regular communication, or another emergent communication, whichever shall first occur."

# And laid his designs down upon the trestle board...

A Masonic trestle board is a design board for a Master Workman to draw his plans and designs upon to give workmen an outline of the work to be performed. Today we would call this a blueprint. It is also one of the three Movable jewels of the lodge.

Some jurisdictions around the world call it a tracing board. The "Tracing Board" may very well have preceded the trestle board. Lodges in Europe use the word "Tracing Board."

Hiram Abif's tracing board is believed to have been made of wood covered with a coating of wax. Each day, he would engrave his Master measurements and symbols into the wax to give the workmen instruction of the work to be accomplished. At the end of the day, he would scrape off the wax and pour a new layer onto the board in preparation for the next day's work.

Much later, in the days where lodge was held in secret areas, once lodge was in session, the Tiler (or Tyler) would draw an oblong (rectangular) or oblong square depiction into the dirt that represented the form of the lodge. Therefore, "Squaring the Lodge" becomes a necessity so that brethren would not erase the writings and symbols drawn within this depiction of the lodge so carefully crafted by the Tyler in the dirt of the hill or vale.

Through the ages, Masonic Tracing Boards were drawn with charcoal or chalk on the floor of taverns where lodges were held in the 1700's. Afterwards, either the Stewards or Entered Apprentice would remove all traces of these drawings. This led to the creation of cloths or rugs

which could be placed onto the floor then rolled up when the meeting was complete. As time passed, these were hung on an easel creating a trestle board.

Today, our trestle board has become an instrument for the Master to draw his designs for character and spiritual growth. It is a symbol of Instruction, Education and Law. What does the trestle board then signify? "It is the symbol of memory, of that precious faculty given to us to mold our judgment by preserving the record of all we perceive." (Palmer, A working Ritual in English)

I hope you enjoyed this brief article and hope that you are encouraged to do your own research.




